OVERDOSE DEATHS INVOLVING FENTANYL HAVE QUADRUPLED IN THE RECENT YEARS



FENTANYL IS RESPONSIVE TO NALOXONE IN THE EVENT OF AN **OVERDOSE**

MAY REOUIRE 2-3 MINS TO RESPOND TO THE NALOXONE ONCE **ADMINISTERED & RESCUE BREATHING MAY BE REOUIRED**

ADDITIONAL DOSES OF NALOXONE **MAY BE REOUIRED**

IF SOMEONE DOES NOT RESPOND TO NALOXONE, THEY MAY HAVE BEEN WITHOUT OXYGEN FOR TOO LONG BEFORE BEING RECEIVING **NALOXONE**

WOODEN/RIGID CHEST SYNDROME-FENTANYL OR FENTANYL ANALOGS **CAN CAUSE SEIZURE LIKE SYMPTOMS LIKE:** MUSCLE SPASMS, LOCKED LIMBS, & A RIGID CHEST THAT CAN PREVENT A PERSON FROM BREATHING **PROPERLY**

REDUCING OVERDOSE RISK

WHEN USING, ASSUME THERE IS A RISK OF **OVERDOSE NO MATTER WHAT YOU ARE** USING

USE SLOW & USE LESS: A LITTLE GOES A LONG WAY. REMEMBER, AN OVERDOSE CAN **HAPPEN VERY QUICKLY**

TRY SNORTING/ SMOKING INSTEAD OF **INJECTING: INJECTING CARRIES THE** HIGHEST RISK OF OVERDOSE, PLEASE NOTE THAT OVERDOSE IS STILL POSSIBLE WITH **SNORTING AND SMOKING.**

SPACE OUT YOUR DOSES

TRY NOT TO USE ALONE. TRY TO USE WITH SOMEONE(S) YOU TRUST. IF YOU MUST USE ALONE. HAVE SOMEONE CHECK ON YOU AROUND THE TIMES THAT YOU USE.

IF USING IN A GROUP, TRY NOT TO USE AT THE SAME TIME. TRY TO HAVE AT LEAST ONE PERSON WHO CAN STAY ALERT AND PROVIDE NALOXONE IF NEEDED

TEST YOUR DRUGS

ALWAYS CARRY NALOXONE/ NARCAN. KNOW HOW TO IDENTIFY AN OVERDOSE AND HOW TO USE NALOXONE/ NARCAN
